Voting member of Church Council (as per Constitution).  
Elected for a 2-year term.

## ***Lead Pastor***

Voting member of Church Council (as per Constitution).  
Voting member of Deacons Committee.  
Ex-Officio member welcome at all other Committee meetings.  
Reports to Church Council for day-to-day activities.  
Reports to HR Committee for Compensation and Personnel-Related Issues.  
Called by membership and granted a term by contract.

## ***Young Life Pastor***

Reports to Lead Pastor for day-to-day activities.  
Reports to HR Committee for Compensation and Personnel-Related Issues.  
Called by membership and granted a term by contract.

## ***Korean Service Representative***

Voting member of Church Council (by Membership Directive).  
Selected by Korean Congregation.

### ***Administrative Assistant***

Reports to Lead Pastor for day-to-day activities.

Reports to HR Committee for Compensation and Personnel-Related Issues.

### ***Deacons Committee***

1 Representative of Deacons is a voting member of Church Council (by Membership Directive).

Deacons elected for 3-year terms.

### ***Sparrow Group***

The Sparrow Group members are appointed for 1-year terms by the Deacons Committee.

### ***Worship Committee***

1 Representative is a voting member of Church Council (by Membership Directive).

Members are elected for 2-year terms.

### ***Christian Education Committee***

1 Representative is a voting member of Church Council (by Membership Directive).

Members are elected for 2-year terms.

### ***Christian Education Appointees***

The Librarian, Sunday School Superintendent, Youth Coordinator, WCP Coordinator and DVBS Coordinator are appointed for 1-year terms by the Christian Education Committee.

### ***Community & Hospitality Committee***

1 Representative is a voting member of Church Council (by Membership Directive).

Members are elected for 2-year terms.

### ***Food Committee***

1 Representative is a voting member of Community & Hospitality Committee.

Members are appointed by Community & Hospitality Committee for 1-year terms.

### ***Facility Management Committee***

Reports to Church Council, but not a voting member on Church Council.

Members are elected for 2-year terms.

### ***Human Resources Committee***

Reports to Church Council, but not a voting member on Church Council.

Members are elected for 2-year terms.

### ***Treasurer / Financial Stewardship Committee***

Treasurer reports to Church Council, but not a voting member on Church Council.

Treasurer is appointed for a 1-year term by Church Council.

Financial Stewardship Committee members are elected for 2-year terms and report to the Treasurer.
